2012 HORSE SHOW – GENERAL ENTRY INFORMATION

PLEASE NOTE ENTRY CLOSING DEADLINE:

ALL HORSE SHOW ENTRIES MUST BE POSTMARKED BY MIDNIGHT NOVEMBER 15.
LATE ENTRIES MUST BE POSTMARKED BY DECEMBER 30
AND SUBMITTED WITH APPROPRIATE LATE FEE.

1. Payment for entry fees and additional passes must be submitted with entries. **Any entries received without payment will be returned.**
 2. Please type or print legibly all information required on Entry Applications and Agent/Summary Sheets.
 3. All entries must include appropriate signatures.
 4. Copy of horse registration papers must accompany entry.

**ALL ENTRIES MUST BE SUBMITTED WITH AN AGENT/SUMMARY SHEET.
ONE AGENT/SUMMARY SHEET IS REQUIRED FOR EACH GROUP OF ENTRIES.**

AGENT: All correspondence – including confirmation of entries, passes and premiums will be mailed to the agent. Premium checks will be made payable to the owner – mailed to agent's address. (Owner can serve as Agent).

OWNER: Owner of the animal will be as it appears on the registration papers at the time the entry application is submitted.

CONFIRMATION OF ENTRIES: Once an entry is received and processed, the agent will receive a confirmation of the entry along with the appropriate passes. Please open immediately. If the confirmation of entries does not agree with your understanding of the entries, please notify our office immediately. Class changes or additions will not be permitted after 12 noon the day preceding the class involved.

TACK STALLS: Tack stalls should be ordered on Horse Show Agent/Summary Sheet and paid for with entries. If sharing tack stalls, **DO NOT** pay for tack stall with two separate checks.

STALL REQUESTS: Any requests to be stalled with someone who is not acting as your agent should be indicated on your agent summary sheet with the exact name of the owner/agent you wish to be stalled with. The most effective way to insure that a group will be stalled together is for someone to act as agent. Otherwise every effort will be made to accommodate stalling requests but there is no guarantee.

MEMBERSHIP CARDS: Current individual membership cards must be shown at stall office before entry numbers will be issued. Please refer to each breed in the Premium List for membership card requirements.

R.V. HOOK-UPS: R.V. sites are not available on the Stock Show grounds. The Stock Show office can provide a list of local R.V. sites. **No overnight camping is allowed on the show grounds.**
